Learning and Demanding Political Action

Prof. Dr. Kai NIEBERT, researcher and Professor of Didactics of Natural Sciences and Sustainability, University of Zurich, impressed the participants with an excellent presentation under the heading "Education in the Anthropocene - Climate Change cannot be Negotiated - a Plea for a Green New Deal" regarding the urgency of the need for action at the political level to save nature and the environment. From his point of view, appropriate legal framework conditions are necessary to reduce environmental pollution in the oceans and the air as much as possible. He therefore sees a close connection between education for sustainability and education for political action.

Question Everything

Prof. David SELBY, founding director of Sustainability Frontiers and Professor at Dublin City University, Ireland, explained a whole new dimension of education for sustainability in his very interesting lecture "Transformative and Transnational Learning for a World in Transition - New Challenges in Education for Sustainable Development".

Based on his findings, which related the different scientific descriptions of transformative teaching/learning, Prof. SELBY introduced his new concept for "Transformative and Transnational Learning for a World in Transition".

Following the development process of a butterfly, he sees the process "Metamorphic Learning Sustainability" as an opportunity to make a major contribution to sustainable development through education for sustainability. First, participants in the learning process should question their actions and processes and then flip systems and processes upside down, in order to develop new sustainable forms, strategies and processes, so that a more sustainable world is ultimately created.

ProfESus - Developing a Sustainable Mindset

Prof. Johanna MICHENTHALER, lecturer at the University of Agricultural and Environmental Education, presented the elements of a European project ProfESus under the topic "Future-oriented Specialists develop a Mindset for Sustainability".

In her very engaging presentation, she convinced the participants of the innovative approach to integrate the desired competencies for sustainability at all levels and processes of vocational training. The ProfESus Concept provides teachers with valuable support in implementing innovative educational approaches in

A SOLID START FOR IFHE UN ACTIVITIES IN 2019: PARTICIPATION IN NEW YORK COMMISSIONS AND SIDE EVENTS

With active contribution to major UN events, the 57th Commission for Social Development and the 63rd Commission on the Status of Women, IFHE started off its 2019 UN activities on a positive note. Both Commissions are held annually and are attended by representatives of UN members states, UN entities and ECOSOC accredited NGOs such as IFHE. They are accompanied by numerous activities organised outside the formal programme which provide an excellent opportunity for discussion and exchange.

The theme of the 57th Session of the Commission for Social Development (CSocD57) in February focused on "Inequalities and Challenges to social Inclusion through fiscal, wage and social Protection Policies".

Together with other NGOs, IFHE presented an oral statement to the Commission outlining the necessity of support to families, parents and caregivers. The statement reminded the UN of the importance of family as crucial contributor towards the achievement of the Sustainable Development Goals, especially by breaking the intergenerational cycle of poverty, recognising and valuing unpaid care and domestic work, and creating just, inclusive and secure societies. The statement is fruit of a cooperation that started in October 2018, when an IFHE Representative took part in a conference on parenting organised by the Doha International Family Institute.

Through new contacts that IFHE acquired during the conference, the federation was also invited to officially co-host two side events during CSocD57 which provides an excellent opportunity to enhance IFHE's visibility.

One side event is the DIFI interactive panel discussion among representatives of Government, civil society and UN entities on measures to support families and their capacity to facilitate intergenerational transfers.

One of the speakers invited is Renata KACZMARSKA, United Nations Focal Point on the Family at the Social Inclusion and Participation Branch, Division for Inclusive Social Development Department of Economic and Social Affairs (UNDESA). The other side event is organised by IFFD with a focus on unpaid care and domestic work during which our UN Representative Anita FERRON received the IFFD Family Award 2019.

Right after CSocD57, the 63rd Session of the **Commission on the Status of Women** (CSW63) takes place at the United Nations Headquarters in New York from 11th – 22nd March. Its priority theme are "Social protection Systems, access to Public Services and sustainable Infrastructure for Gender Equality and the Empowerment of women and girls".

IFHE, through the NGO Committee on the Status of Women Vienna, presents a written statement to the Commission. The statement calls for action in various fields, for example policies to narrow gender pay gaps, enhance women's access to income and pensions, and provide family allowances for children and the design of innovative gender-inclusive infrastructure projects to ensure women's security in all public spaces and on public transportation.

Four IFHE Representatives take part in this year's CSW and the numerous side events at the UN premises and activities organised outside the formal programme. A more detailed report follows in the next Newsletter.

Since 1982, we have celebrated World Home Economics Day to promote family and consumer issues. The 2019 theme, "Creativity and Innovation in Home Economics for Sustainable Development", highlights our profession's contribution to a sustainable future.

Sustainable development begins at home. Home Economics as a field concentrates on households as building blocks of societies and aims at improving the quality of life for individuals, families and their communities. It respects households as an environment, where individuals are educated to reach their potential, understand their local and global interdependence, and positively contribute to communities.

Home Economics encompasses a diversity of disciplines and as such stands for the integrated approach needed to achieve sustainability which is higlighted by the UN Sustainable Development Goals. The achievement of these Goals will require knowledge in many areas that are covered by Home Economics experts such as: food, nutrition and health, housing, textiles, consumer behaviour, household technology, education and community services.

Increased Home Economics knowledge paves the road towards achieving many of the UN Sustainable Development Goals. It is a strength of our profession that it draws on the expertise of both, researchers and practioners, to contribute to

 Gender Equality. Home Economics invests in gender equality at household level. Here is the nurturing ground for behaviour and values which, once acknowledged among household members, can be confidently pursued beyond the household.



- Good Health and Wellbeing. Health problems deprive affected households of resources households and impede development. Home Economics focusses on health ecudation and research, especially for vulnerable groups.
- Clean Water and Sanitation. Water may be perceived as a local good, but our field also educates and advocates on the global implications of local household activities and consumption.
- Responsible Consumption and Production. Home Economics is concerned with how individual behaviour, priorities and choices shape our future living at household level, in local communities and on our globally interdependent planet.

Patricia Etuna MBAH (Ph.D., M.Sc., M.Ed., B.Ed./Sc.) is a Professor of Home Economics with Michael Okpara University of Agriculture, College of Applied Food Sciences and Tourism, Department of Home Economics/Hospitality

Management & Tourism, Umudike, Umuahia, Abia State. She holds a Doctor of Philosophy degree in Home Economics, M.Sc. in Nutrition and Dietetics, M.Ed. in Educational Administration and a B.Ed./Sc. in Home Economics. Her research studies are Home Economics based with special interest in nutrition, family, health related issues and family sustainability. Prof. Patricia Etuna MBAH was formally with the Federal College of Education (Technical) Akoka, in Lagos, Nigeria where she served as Head of Department of Home Economics for over ten years and Dean of School of Vocational Education subsequently. She rose to the pinnacle of academic progression in the College of Education system in 2005 as a Chief Lecturer and a Fellow of Women in Colleges of Education (WICE) and a Fellow of the Chartered Institute of Administrators, Ghana (CIA). Her enthusiasm for further higher academic researches and development motivated her transfer of service to Michael Okpara University of Agriculture, Umudike in 2013 where she was able to explore her quest for higher academic research and competitiveness.

She became the Head of Department of Home Economics/Hospitality Management & Tourism in Michael Okpara University of Agriculture, Umudike, in February 2014. On the 4th of March 2016, she was elected at the University Senate the Deputy Vice Chancellor Administration in Michael Okpara University of Agriculture,

Umudike. She has since her assumption of duty in the University served very diligently in various committees including but not limited to being the Chairman of Examination and Time Table Committee (ETTC).

She has over sixty-eight publications made up of books, journals, monographs and technical reports. She is actively involved in her professional organisation "International Federation for Home Economics (IFHE)". She is currently the Vice-President Africa Region, Chairperson of the Programme Committee on Food Security, Nutrition and Nutritional Health (FSNH) and the Liaison coordinator for IFHE Nigeria Liaison group. She is certified as International Professional Home Economics (IPHE) by IFHE. She is also the President of Home Economics Professional Association of Nigeria (HEPAN) and the Council: Home Economics Council of Nigeria (HECON) and a Fellow of HEPAN. She is also an active member of Nutrition Society of Nigeria (NSN) and Society for Nutrition Education (SNE).

Prof. Patricia Etuna Mbah is happily married with five children (Two girls and three boys).

Patricia's professional Ideology: Professionals should develop a philosophy with rational practice that is geared towards reflection on progressive roles and ideas that will reshape the profession, the family and the global society. The interdisciplinary areas of specialisations in Home Economics are challenging, character-defining and spirit satisfying if the implementation process is done with utmost consciousness and commitment. The socio-economic, health, cultural, political, ecological, legal and technological environment are constantly in a state of flux therefore Home Economics professionals must rise up to this challenging environment and provide basis upon which strategies and solutions could be proffered.

I categorically state that a professional should act in a manner which is consistent with the vision of the profession and "If a person fails to stay philosophically well, she/he cannot act professionally".

Profile for Audrey A. JONES-DRAYTON M. Ed., IPHE, CPHE, The Caribbean



Audrey JONES-DRAYTON is currently the Deputy Principal, Administration (Ag.) at the Samuel Jackman Prescod Institute of Technology, Barbados. She holds a Master of Education Degree in Teacher Education from the University of the West Indies, Mona, Jamaica, a Bachelor of

Education Degree (Hons.) from the College of Arts Science and Technology now the University of Technology, Jamaica majoring in Clothing, Housing and Design, post graduate qualifications in both Educational Administration (Dist.) and in Credit Union Operations from the University of the West Indies, Cave Hill, Barbados and a trained teachers' certificate with a major in Home Economics from the Lillian Dewar College of Education, Guyana.

Ms. JONES-DRAYTON has been a member of the Caribbean Association of Home Economists Inc. (CAHE) for the past thirty-five years. She is also a President of Honour having been President for the period 2009 - 2013. She is presently a Consultant for the Association. Ms JONES-DRAYTON is a member of the International Federation for Home Economics (IFHE) and is the former representative the Region of the Americas on the IFHE Executive Committee 2012 - 2016. She now performs the duty of IFHE Liaison for the Caribbean.

Profile for Dr. Shadis NASER Eldin ELSAYED, Sudan



I obtained a Ph.D. in Agriculture (Rural Development); M. Sc. in Alternative Energy for Developing Countries; and Diploma (4 Years) in Family Sciences and Community

Development; Ahfad University for Women-Omdurman- Sudan 1981 and this equipped me with the required knowledge that qualify me to contribute in the teaching of health-related subjects. I also taught Home Economics at Omdurman High Secondary School for two years immediately after my first degree graduation.

Unfortunately, it was very difficult for IFHE's Sudan Members to communicate after the Khartoum Conference due to weakness of the electronic network.

Also, the registration of the Sudanese Home Economics Organisation was terminated after the sudden passing of Prof. Sidiga WASHI (may God rest her soul).

Regarding the present situation of the Home Economics in Sudan, it is confronted with many obstacles which causes can be summarised in the following:

Lack of commitment of some members beside the poor communication amongst members within the different Programme Committees.

Over-burden and overload of most of the members in their efforts to avail a dignified and reasonable standard of living to their families.

Lack of ample time to allow releasing the potential of the innovative and creative capabilities of our Home Economists.

Lack of coordination amongst Home Economists from outside the university.

Despite the weak electronic communication and the political unrest in our country, we will be looking forward to keeping the voice of Sudan's Home Economists heard through more active contribution of our members.

RARE DOCUMENTS ILLUSTRATE EARLY FEMALE AND HOME **ECONOMICS EDUCATION IN EGYPT 1937 – 1980**

Professors Manal K. ABDEL-RAHMAN and Aly R.
